## 2B. Project Description

**1. Provide a description that addresses the entire scope of the proposed project and how the Collaborative Applicant will use grant funds to comply with 24 CFR 578.7:**

The Planning Grant project is sought to enhance continued achievement of goals in ensuring coordination activities, implementing evaluations and monitoring procedures to reveal noted progress/lack of progress, increased awareness and growth, areas requiring special attention, and those that have resulted in stagnant growth in the goal of eliminating homelessness. A constant is determining what increases and what dramatically lowers barriers to the community's progress in meeting goals of accessing housing. This information is gained through efforts of monitoring and analyzing the CoC activities. CoC TX-624 is responsible for assisting with shelter for persons in the crisis of homelessness in 16 of Texas' counties. Fifteen of these counties are considered rural and often lack available resources. This project will include the salary and space costs for one (1) part-time planning staff person who will work in partnership with the CoC Lead agency, State, County, City and other stakeholders such as nonprofits, businesses, and private funders. The staff person will also participate in the Texas Homeless Network to align standards and efforts for homeless services and promote funding priorities. The planning staff member will be responsible for implementing the evaluations of CoC programs. Staff, working with the CoC, will consult with recipients to establish performance targets appropriate for population and program type. Benchmarks will be used to evaluate outcomes in programs. Mandatory and needed activities such as, analysis of system gaps and disparities, program performance, and fiscal monitoring of CoC funded projects will be conducted. Key targets which directly relate to responsibilities including monitoring grantee compliance, monitoring grantee compliance with HUD drawdown requirements and expense eligibility will be reviewed for any necessary updates in training. Training and technical assistance to grantees will also be requested as applicable. It will also allow for material development including project applicant training material development and conducting training meetings, collaborative application project management, as well as post-competition debriefing meetings.

The timeframe for all activities will be twelve (12) months. The CoC will incorporate all planning activities within its guidelines and will monitor to ensure completion within the specified grant cycle. Many of the proposed activities will remain ongoing having gained the knowledge of implementation during this grant cycle. The Lead will be responsible for maintaining copies of the proposed activities and management plan with the proposed completion deadlines. This will include the completion and submitting of HUD mandated reports as well.

**3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?**

The requested funds are intended to assist in building capacity and support of the CoC membership to provide a strong foundation enabling the CoC to increase its effectiveness and community impact. The continued emphasis on long-term strategic planning and reinforcing capacity through staffing will support the CoC to more effectively use data analysis and evaluation to drive planning and strategic approaches that prevent and eliminate the malady of homelessness. The proposed activities will help the CoC and served communities in both communication and marketing of data to be more efficient and to become the main source, or a one stop shop for all homeless-related data in the community.
